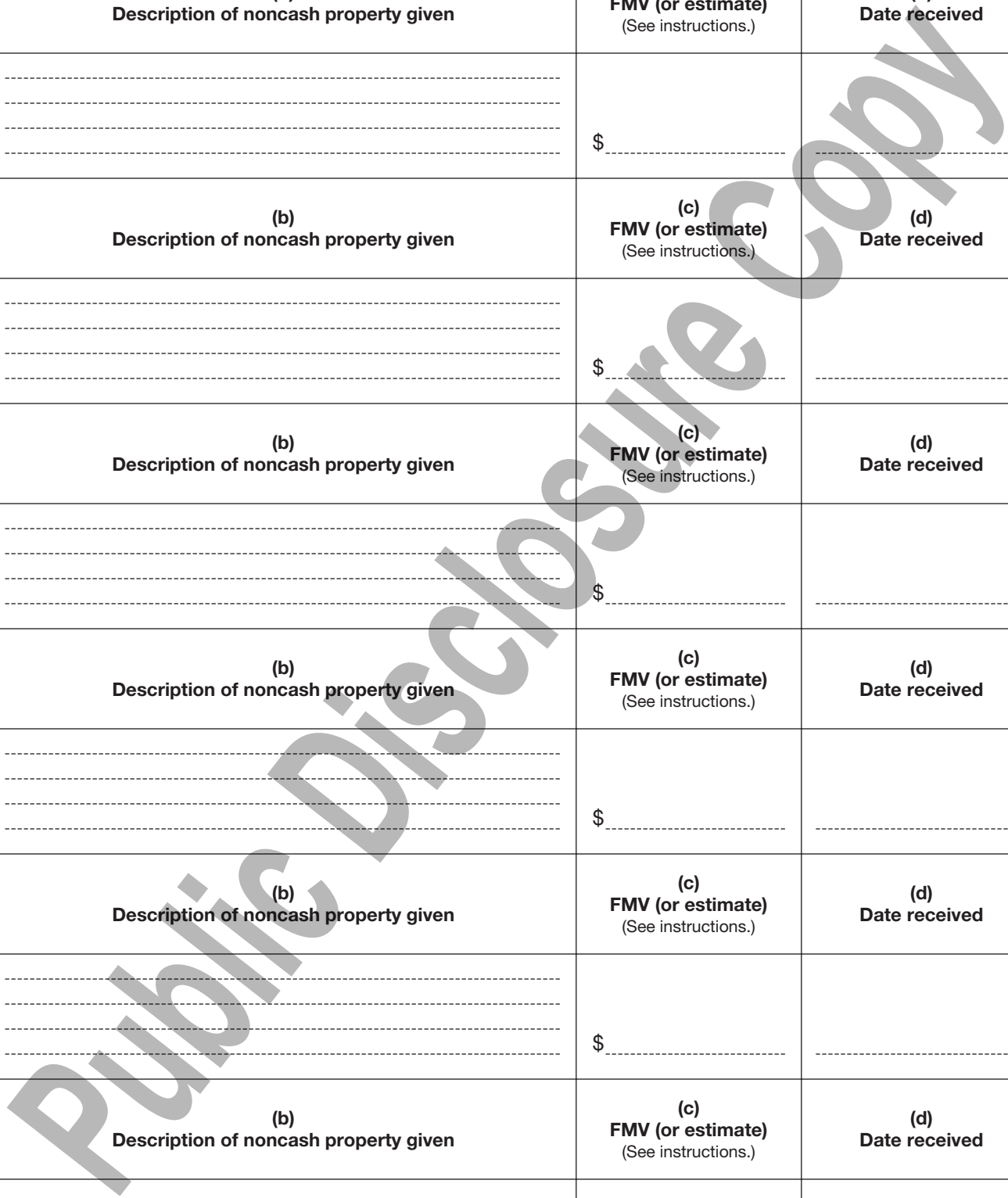

This includes the executive director who serves as an ex officio member of the board and is hired and reviewed annually by the board. The Office Personnel Manual provides the executive director with emergency authority to sever from employment any employee whose conduct or activity immediately and substantially jeopardizes the ability of the organization to render effective service to its membership or undermine the purposes of the organization.

Pt VI, Line 7a: Beyond Pesticides holds an annual election to 1/3 of its board of directors. A nominations committee of the board of directors puts together a slate, collecting nominations from the board and membership. A ballot is distributed to the membership annually with candidates and an opportunity for a write-in.

Pt VI, Line 15a: An outside HR organization conducts a thorough market compensation study of similar organizations by evaluating data through surveys and reports such as Candid (previously GuideStar), ASAE non-profit survey, Association Trends non-profit survey, Salary.com and others to determine comparability data. The outside HR organization presents the findings to the Board of Directors for a discussion and vote on the appropriate base salary increase (if any) and potential bonus in executive session.
